This is in response to your Request for Public Records, per N.J.S.A. 47:1A-1 et seq., the Open Public Records Act (OPRA), received by this Office on November 4, 2022. You requested the following:


“Any and all arrest records, incident reports, jail records, traffic violations, traffic incident reports, and criminal reports associated with “Craig [REDACTED]” from March 01, 2017 to present. A transcript and/or audio recording of any and all interviews with “Craig [REDACTED]” from March 01, 2017 to present.”

Please be advised that a search of our files indicates that there are no documents or records made, maintained or kept on file by the Burlington County Prosecutor’s office responsive to your request for “Any and all arrest records, incident reports, jail records, traffic violations, traffic incident reports, and criminal reports associated with “Craig [REDACTED]” from March 01, 2017 to present” Please be further advised that while there are documents responsive to your request with regard to “transcript and/or audio recording of ... interviews with Craig [REDACTED]” on file with the Burlington County Prosecutor’s Office they are part of an ongoing investigation and have been withheld pursuant to N.J.S.A. 47:1A-3.a. Please be further advised that interview transcripts and recordings are also exempt from disclosure as criminal investigatory records (CIR), pursuant to N.J.S.A. 47:1A-1.1.

Per N.J.S.A. 47:1A-6 Proceeding to challenge denial of access to record, you are advised that you have the right to challenge this decision by filing an action in the Superior Court of New Jersey in Burlington County or by filing a complaint with the Government Records Council.
